# Health Sciences Association of British Columbia 2023 Annual Convention Minutes

### April 19, 20, and 21, 2023 Vancouver Hyatt Regency Hotel

### Wednesday, April 19, 2023 – Morning Session

Kane Tse, President, welcomed delegates, guests and staff to HSA's 52<sup>nd</sup> Annual Convention and acknowledged the convention is taking place on the unceded territories of the Coast Salish and the nations of the Musqueam, Squamish, and Tsleil-Waututh First Nations, where we are gathered.

Tse provided an update on a racist incident that occurred at the Hyatt Regency Vancouver in the February with the BC Association of Aboriginal Friendship Centres. HSA President Kane met with the Hyatt 's General Manager and expressed HSA's deep disappointment in the hotel's response to the incident. Shortly after, the Hyatt issued a full apology, which included a plan for education for all staff, and a refund to the BC Association of Aboriginal Friendship Centres for their financial loss from withdrawing their event from the hotel. HSA received confirmation from the BCAAFC that the apology was accepted, and thanked HSA for its support.

Tse advised that HSA is meeting in this hotel knowing that the work on achieving reconciliation is a long and difficult one, and that actively working towards reconciliation requires personal reflection and acknowledgement of the part we play in systemic racism, and also demands that we speak up, take action, and actively support those who continue to suffer from anti-Indigenous racism.

Tse then informed delegates of the COVID-19 safety plan that is in place, that a prayer and quiet rooms are available during convention and then explained that the voting system for this convention will be by a show of hands and conducted electronically, if needed. Tse then asked Julien Bodart from Lumi Global to explain the process and conduct test votes.

Shannon Chartier, Convention Registrar, delivered the credentials report.

# DIVERSITY AWARENESS AND ANTI-HARASSMENT STATEMENT

Tse reviewed the Diversity Awareness and Anti-Harassment Statement and advised that Pam Hosie, Region 2, Luita Siep, Region 7, Jai Turcotte, Region 2, Helen Wong, Region 6, and alternate Nadine Blake, Region 8, will act as the Ombudspersons for the 2023 Convention delegates. Support for the Ombudspersons is independent Legal Counsel, Dana V. Kiefer, Associate, Lawson Lundell LLP.

Tse said the commitment to ensuring a harassment-free workplace for HSA staff is taken seriously and disrespectful or harassing treatment of staff will not be tolerated. Ombudspersons available for HSA staff on Wednesday are Sharon Geoghegan and Tara Locke, on Thursday, Graeme Johnston, Monivoi Vataiki, and on Friday, John Hindle and Ashley Lopez.
