How to participate in the telephone town hall: You should receive a phone invitation at your home phone number approximately two days in advance.

On the evening of June 19, your phone will ring at approximately 7pm. If you wish to participate, please pick up the phone and stay on the line. You will be able to listen to a presentation on bargaining, and have opportunities to ask questions of the town hall host. Experts will be on the line to address your questions.

You'll be joining 15,000 other community social services professionals from across BC, represented by ten unions.

The provincial government's Community Social Services Employers Association (CSSEA) represents 220 agencies in the sector.
