HSA Labour Council delegates are eligible to attend the meeting, but will not have voting status if their Chapter's delegate entitlement is filled by other members. Wages and expenses will be reimbursed for only one delegate per Labour Council.

As your regional meeting is open to all HSA members, we have provided workplace bulletins to alert interested members. Please note only those members with delegate status will be reimbursed for lost time and expenses. Please ensure that these bulletins are posted.

IMPORTANT NOTE ABOUT REGISTRATION

Each chapter is allotted a certain number of reimbursed delegates according to chapter size (minimum of 1). Please refer to the delegate entitlement form to confirm your chapters' numbers. If you are interested in attending the regional meeting, please confirm your eligibility with your Chief Steward. If eligible, you must register online only.

Chief Stewards will be electronically notified and approve online registration.

Regional Meeting Delegate Entitlement

The Chief Steward is automatically a delegate to the Regional Meeting. Assistant, General, or Site Stewards should replace Chief Stewards who are unable to attend the Regional Meeting.

In Chapters with 49 or fewer members, the HSA Chief Steward or Alternate is automatically a Delegate. This is the only Chapter member allowed to vote at the Regional Meeting and the only member reimbursed for expenses related to attendance at the Regional Meeting.

Chapters with over 49 members are entitled to have an additional delegate for every 50 members (or portion thereof), as per Article 7, Section 5 of the Constitution.

An accompanying list specifies the number of delegates our records indicate each Chapter is entitled to send. If you have any questions about these figures, please contact my office.

These additional delegates must be:

- 1. Employed in the Chapter they seek to represent.
- 2. A member of HSA as per Article 5, Section 1(a) of the HSA Constitution.

In addition, Members-at-Large and Regional Directors are automatic delegates to the Regional Meetings and workshops, but must still register online.

All delegates must register online by midnight on the deadline date listed above. We require two weeks' notice to ensure room bookings. (In the event that a delegate has to make alternate accommodation arrangements, HSA will only reimburse such delegates up to the cost that would have been incurred had the delegate registered by the deadline date).

The Chief Steward should ensure each registrant is provided with the following online registration steps for the Regional and Advanced Disability Management Meetings:
