"(a) To be eligible for election, a member must be in continuous good standing for twelve (12) months prior to nomination. Continuous good standing means no interruptions in active membership in the Union because of suspension, expulsion, withdrawals, failure to pay fines or assessments to the Union.

Furthermore, in order to be eligible for election, the nominee must have attended a minimum of 50 per cent of the chapter meetings held in their chapter in the twelve (12) months prior to nomination. Any member may be exempted from the attendance requirement of this Article if they were unable to attend fifty per cent (50%) of said meetings because of illness, regular employment, or any other good cause.

In the case of an incumbent candidate, the requirement to attend a minimum of 50 per cent (50%) of their home chapter meetings is waived."

- (d) Regional Directors take office at the conclusion of the Convention in the year in which they are elected."

For the purposes of this provision, the size of the region's membership is determined by the number of people within the region paying dues in the month prior to the month of the petition.

Upon receipt of the petition, the Board of Directors will confirm whether the petition satisfies the requisite number of petitioners to warrant the recall of the Regional Director. Should the Board of Directors so confirm that the recall is warranted, the recall will take effect immediately upon such confirmation. No recall petition shall be acted on if it is delivered within six months of the end of the Regional Director's term.
