# Friday, April 19,2013 – Morning Session

# **MINUTES FROM THE 2012 CONVENTION**

Johnson reviewed the Business Arising document and explained the process of implementing resolutions for the 2013 Convention. Johnson reported on items from the business arising document from 2012 Convention:

- Pharmacist market wage adjustment wage cuts proposed by the government was defeated through bargaining.
- Steward Training and Education resolutions related to training and education were addressed through a new comprehensive workshop and these resources are also available online. More details will be presented by the Education Committee.
- Integrated Early Child Care and Education this topic was discussed at our last convention and increased efforts are being made through social media, our involvement with the BC Federation of Labour, NUPGE Women's Committee and the Canadian Centre for Policy Alternatives.

- a) employers are not allowed to use temporary foreign workers (TFWs) to drive down wages and working conditions for other workers in Canada;
- b) workers already living in Canada are given a fair opportunity to fill jobs before they are offered to TFWs;
- c) legal safeguards are in place to ensure the fair treatment and compensation of TFWs employed in Canada; and
- d) TFWs are given a fair opportunity to become landed immigrants and citizens.

- b) resume using an equalization formula to divide these funds among the provinces; and
- negotiate a new Health Accord with the provinces that includes establishing standardized national health care programs, as well as national pharmacare and national home care programs.
