As the global COVID-19 pandemic continues to unfold worldwide, in Canada, and in BC, the situation is changing hourly.

We know that HSA members are on the front line of providing health care and social services to British Columbians who are sick and scared. We are in uncharted waters, and we are all working together to prepare as best we can for what is to come.

Thank you for your continued commitment and dedication to all British Columbians

HSA continues to be involved in regular briefings with BC Public Health and Ministry of Health officials, as well as the Health Employers Association of BC, participating in occupational health and safety meetings three times a week, and meetings to address labour relations issues twice a week. HSA staff are equipped to work from home, and the office in New Westminster remains open with limited staff, who are practicing safe physical distancing and infection control measures.

We have set up a dedicated telephone line for urgent COVID-19 related calls. It is being monitored 8 a.m. to 9 p.m. daily, including weekends.
